APPLICATION FOR THE ANDREW JACKSON MASONIC SCHOLARSHIP

GENERAL INFORMATION

- 1. A maximum of Two (2) \$2,000.00 Andrew Jackson Masonic Scholarships will be awarded in the current academic year to two full-time graduating seniors or current higher education applicants. There will be no discrimination based on the federal legally protected classes. These scholarships are underwritten and sponsored by Andrew Jackson Lodge No. 120, Ancient Free & Accepted Masons in Alexandria, Virginia. Applicant must be an immediate family member of a current or deceased Andrew Jackson No. 120 Lodge member in good standing OR a current Andrew Jackson No. 120 Lodge member in good standing. Immediate family members include spouses, children, and grandchildren.
- 2. The scholarship award shall be considered a gift to the recipient provided that he/she submit confirmation of acceptance of the college or university of their choice.
- 3. The scholarship award will be presented to the recipient by a Member of the Andrew Jackson No. 120 Lodge. If the recipient withdraws from the college or university during the academic year for any reason other than continued illness or personal hardship resulting in an inability to attend; the scholarship award shall then be repaid to Andrew Jackson Lodge No. 120 within two (2) years of the date of the withdrawal. A statement of withdrawal **FOR ANY REASON** must be forwarded to the Scholarship Committee Chairman at the address below.

- 4. Awarding of this scholarship shall be judged on the basis of:
 - a. Quality of the submitted essay
 - b. Complete scholarship application with supporting documents summarized in paragraph 2 under GENERAL INFORMATION
 - c. Required information for tax reporting purposes

- 1. Applicant **must** apply on a current application form posted on the Andrew Jackson No.120 website; which **must** be completed **IN FULL** (additional sheets may be attached to the form, if necessary) or the application **will not** be processed.
- 2. THE FOLLOWING DOCUMENTS ARE REQUIRED TO PROCESS THE APPLICATION.
 - a. A personal essay detailing your reason in applying for the scholarship, to include a brief bio, and your personal and professional goals.

Please submit the essay as a WORD doc or pdf,; with 1 inch margins;

12 pt. Font Times New Roman; and 1-2 pages in length.

- b. A complete Scholarship Application.
- c. Supporting documentation detailed in the GENERAL INFORMATION, Para.2 must be provided if the applicant has been selected for a scholarship award.
- d. Present valid ID to be noted on applicable Tax Forms, if a scholarship is awarded. Andrew Jackson No. 120 will not make or keep any copies of the documents presented. It is the responsibility of the Scholarship recipient to abide by all US Internal Revenue Service Tax laws.
- 3. TO QUALIFY:

THE APPLICATION AND ALL SUPPORTING DOCUMENTATION LISTED ABOVE SHOULD BE SUBMITTED AS A SINGLE PACKAGE TO THE ANDREW JACKSON NO. 120 SCHOLARSHIP COMMITTEE CHAIR BY <u>APRIL 1, 2025</u>. ANY AND ALL APPLICATIONS AND/OR DOCUMENTATION RECEIVED AFTER APRIL 1, 2025 WILL NOT BE PROCESSED.

All materials become the property of the Scholarship Committee and will not be returned. All information will be held in strict confidence within the Scholarship Committee.
